Policies would attract skilled, motivated newcomers who bolster our economy, fill labour gaps, and enrich our culture—ensuring that every Albertan thrives.

A future of selective, fair, and welcoming immigration keeps Alberta strong, prosperous, and true to its people. We set the rules—building freedom with security, opportunity, and unity.

PRINCIPLES OF ALBERTA'S IMMIGRATION POLICY

ALBERTA'S APPROACH IS BUILT ON FAIRNESS, COMMUNITY NEEDS, AND ECONOMIC GROWTH.

- **Points Based System:** Selections are based on merit, including natural-born Canadian status, education, work experience, language proficiency (English/French), health, and overall contribution potential.
- **Economic Focus:** Newcomers must demonstrate in-demand skills for Alberta's key sectors (energy, tech, agriculture) or show intent to start or buy a business, driving jobs and innovation for all residents.
- **Community Integration:** Robust support for settlement, including language training, credential recognition, and cultural orientation programmes, helps newcomers succeed and build lasting ties.
- **Annual Accountability:** Transparent yearly reports from the Immigration Ministry on intake numbers, economic impacts, integration success, and citizenship grants keep policies Alberta-led and adaptive.

CITIZENSHIP, RIGHTS, AND PROTECTIONS

IN A SOVEREIGN ALBERTA, NEWCOMERS ARE WELCOMED WITH OPEN ARMS BUT GUIDED BY CLEAR, TRANSPARENT RULES THAT SAFEGUARD OUR SHARED PROSPERITY.

- **Pathway for Canadians:** Fellow Canadians relocating to Alberta would apply for Alberta citizenship to unlock full benefits like voting and services; fostering loyalty and seamless integration (dual citizenship preserved via negotiations, per constitutional experts like...Keith Wilson).
- **Standards for All:** Applicants meet Alberta-specific criteria; those arriving under prior federal policies (post-2015) may need to requalify for residency or citizenship to align with our merit-based framework—ensuring fairness during the transition.
- **Social Services Access:** Comprehensive supports (healthcare, welfare) reserved for citizens and approved permanent residents, transitioning to private or business sponsorships to avoid taxpayer burdens and reinforce commitment to Alberta values.
- **Balanced Safeguards:** Human rights are upheld under our Constitution, with protections against discrimination, while we prioritize economic sustainability, border security, and no-sanctuary policies for illegal entries.

MORE FACTS

Immigration control is a key tenet of APP's vision for Alberta's sovereignty. It proposes a shift to provincial rule over immigration intake, policy, and eligibility.

- APP proposes a points-based immigration system that awards points for natural-born Canadian status, education, work experience, language proficiency, health, entrepreneurial plans, and overall contribution potential—ensuring Alberta attracts newcomers who strengthen our economy and share our values.
- The platform has raised questions over federal policies since 2015, suggesting that newcomers admitted under them would have to re-qualify through Alberta's new screening program or risk deportation. Estimates suggesting tens of thousands could be sent to Ottawa or their country of origin if they do not pass the new test.

APP believes this approach allows Alberta to tailor immigration for economic prosperity, filling urgent local labor needs while ensuring greater cultural and values alignment.
